ARTICLES OF INCORPORATION OF  
BREVARD THUNDER, INC.  
A FLORIDA NONPROFIT CORPORATION

ARTICLE I - NAME

The name of the Corporation is: BREVARD THUNDER, INC.

ARTICLE II - DURATION

The duration of the Corporation is perpetual.

ARTICLE III - PURPOSES

The purpose of the Corporation is as follows:

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this Corporation is to provide service to the youth in and around Brevard County by way of forming and operating a girls fastpitch softball team for competition in ASA, ISA and NSA sanctioned competitive softball tournaments held in the United States.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the Corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

#### ARTICLE IV - MEMBERS

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. #### ARTICLE V - Initial Registered Agent and Office

The initial registered agent is Doug Oldham and the initial registered office is 1550 Hidden Wood Road, Cocoa, Florida 32926.

#### ARTICLE VI - Initial Board of Directors

The initial Board of Directors shall have four (4) members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the Bylaws but shall in no case be less than three.

#### ARTICLE VII - Officers

The officers of the Corporation shall consist of a President, Vice-President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. 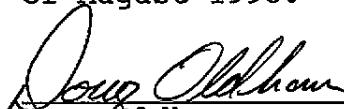
ARTICLE IX - Nonstock Basis

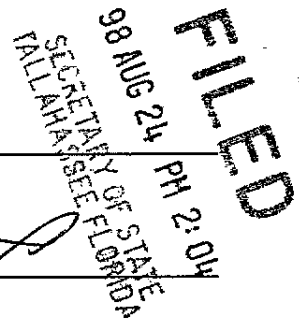
ARTICLE X - Corporate Address

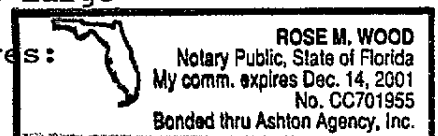

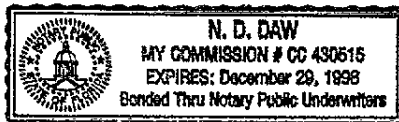
