- ONE: The name and address of this principal corporation is **Extended Hand, Inc., 2920 N. W. 44th Avenue, Fort Lauderdale, FL 33313**. The corporation is organized pursuant to the **Florida, Nonprofit Corporation Code**.
- TWO: This corporation is a nonprofit public benefit corporation and is not Revenue organized for the private gain of any person. The corporation is under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. It aims to establish enhanced, structured support services for children who have been placed in shelter and/or foster care to ensure their physical and emotional safety. The programs will consist of, but shall not be limited to: Foster Childcare, Health Care, Housing for the Foster Children, Substance Abuse Awareness and Prevention Homeless Care, Counseling and other programs to aid those in foster care who are in need.
- THREE: The duration of this corporation shall be perpetual, no stock, and shall have no members.
- FOUR: The address of the registered office is **Extended Hand, Inc., 2920 N. W. 44th Avenue, Ft. Lauderdale, FL 33313**, and the name and address of the registered agent of the corporation shall be **Johnnie Mae McFarland, 2920 N. W. 44th Avenue, Fort Lauderdale, FL 33313**

(a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Code.

- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
