ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

Article I NAME

The name of this corporation shall be: Health Resource Center for Palestine, Inc (HRCP, Inc).

Article II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

1313 S. Military Trail, Suite 283 Deerfield Beach, FL 33442

Article III PURPOSE(S)

Health Resource Center for Palestine, Inc is dedicated to the improvement of health care in Palestine and among Palestinian Refugees in Lebanon. The methods used to reach this goal include: educating and training health care workers from among the target populations via providing scholarships and facilitating continuing education opportunities; providing volunteer medical and ancillary personnel when necessary, donating equipment, medicine and medical supply needs; funding of clinics and prevention programs; funding and assisting with related medical research programs; educating others about the health care crisis faced by Palestinians; assisting grass roots organizations among the target population in achieving the already mentioned goals with both technical and monetary support. In order to address those problems unique to the Palestinian population, the Health Resource Center for Palestine, Inc. will from time to time engage in a variety of fundraising activities and may receive not only monetary donations, but also donations of medical equipment, medicines and other humanitarian necessities.

Article IV MANNER OF ELECTION OF DIRECTORS

Directors are to be appointed by board consensus based on competence and relative experience of the nominee, such experience to include a health-care related background, and also based on conditions listed in sections "a" through "g":

Section a. The director will not at any time have the ability to alter Article III in any way that will change the scope of purpose to any other than addressing the needs of the Palestinian population in particular or those under the guardianship of Palestinians by way of legal fostership or marriage. Exceptions may be made only on a case by case basis with a unananymous board decision and only if in compliance with conditions of sections "b" and "c" of Article IV.

Section b. The director will not be permitted to engage HRCP, Inc. in any activities contrary to Islamic Law, and if a board consensus decides, based on ample evidence, that this has occurred, said director will be immediately removed from his post and be replaced by the assistant director pending new appointment by a board consensus based on the above mentioned qualifications.

Section c. Neither the director, nor any board member, may, at any time engage Health Resources Center for Palestine, Inc in any contract or activity with any Organization or Individual that has openly threatened or carried out acts of aggression against Palestinians or Muslims in general nor may the director permit the designation of any money or property donated to HRCP, Inc. to aid people associated with said organizations or individuals.

Section d. The director must be able to provide full disclosure of all organization-related expenses to the board upon request by the board and at all scheduled financial meetings. Failure to do so without just cause will result in dismissal.

Section e. The director must be able to communicate effectively in both Arabic and English.

Section f. The director must hold American citizenship.

Section g. The director may be a male or a female.
