ARTICLES OF INCORPORATION

The undersigned incorporator and the other listed incorporators of a Not for Profit corporation, pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Creation Education Station, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 19109 Alice Circle, Lutz, FL 33549.

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is to provide the community with creation science education, materials, services, and museum exhibits. This includes hands-on science teaching, tutoring home school and other students, lectures, field trips, camps, after-school care, library and gift shops, scientific research, and any other legitimate and related educational and scientific pursuits.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which new directors are elected or appointed shall be by majority agreement of the Board of Directors or, in the event of their incapacitation, such alternative persons as they shall have appointed at their annual meeting to temporarily act on their behalf. Furthermore, a qualification for being a member of the Board of Directors shall be agreement with and adherence to the organization's State of Faith, Mission Statement, purposes, and goals; agreement is to be signified by signing a copy of the foregoing documents.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.
