## ARTICLES OF INCORPORATION OF S. S. A. TROOP 206, MARGATE, FL INC

Article 1. Name. The name of the corporation is B. S. A. Troop 206, Margate, Fl. Inc.

Article 2. Duration. The duration of the corporation is perpetual.

Article 3. Purpose. The purpose of the corporation is as follows:

This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is to promote through cooperation with other agencies, the ability of youth to do things for themselves and others, and to teach them patriotism, courage, self-reliance, and kindred virtues through the program of Boy Scouts of America. In achieving this purpose, emphasis is placed upon its educational program and the oaths, promises, and codes for character development, citizenship training, and mental and physical fitness, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## Article 4. Powers:

- A. The Corporation will exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, except as restricted by section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation may accept gifts, grants, endowments, devises, bequests, and contributions to be used in furtherance of its purposes.
- B. This Corporation is organized and will operate exclusively for charitable, religious, educational, and scientific purposes. The Corporation may make distributions to organizations that qualify as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, for furtherance of the stated purposes.
- C.. No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its members, directors, or officers. The Corporation shall not engage in any business practice that would give rise to taxation on those practices, make any investment to threaten the tax-exempt status, have any excess business holdings, or make taxable expenditures. Notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation, nor shall it engage in any activity to directly or indirectly influence legislation or participate in any political campaign.
- D. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, for a public purpose.
- E. The Corporation shall be composed of unrecompensed volunteers and neither they nor the organization, nor its directors, incorporators, or officers shall assume any personal or public liability.
