# ARTICLES OF INCORPORATION

## EASTSIDE ASSEMBLY OF GOD OF TALLAHASSEE, INC.

The Undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

### Article I Name

The Name of this corporation shall be "Eastside Assembly of God of Tallahassee, Inc."

### Article II Address

The principle place of business and worship of this corporation shall be 1160 Capitol Circle, Tallahassee, Florida 32311.

### Article III Purpose

The general purpose of this corporation is to establish and operate a Church and associated auxiliary programs. Eastside Assembly of God of Tallahassee, Inc., shall subscribe to the Doctrine of Scriptures of the Fundamental of Truths of the Assemblies of God as described in the By-Laws of this corporation. This corporation shall operate exclusively for such religious, charitable and educational purposes as qualify as a non for profit, tax-exempt organization under federal and state law, which may include but not limited to church and worship services, sunday school programs, nursery and day care schools and/or centers and/or programs, children and youth services and programs, outreach programs, educational programs and institutions, crisis and/or disaster aid and/or mass care programs and/or any other programs and auxiliaries which will advance our religious beliefs, relieve the poor and distressed.

### Article IV Directors

The directors of this corporation shall be the trustees, directors and advisors and may be elected or appointed or dismissed as regulated by the by-laws of the corporation.

### Article V Powers

This corporation shall have all the powers, rights and privileges of a not for profit corporation as described in Section 617.0302, Florida Statutes.

### Article VI By-Laws

The Directors of this corporation shall adopt and publish by-laws to govern this not for profit corporation and must submit to operate and conduct corporate business as regulated in those by-laws.
