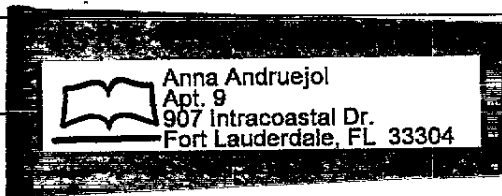

**ONE:** The name and address of this principal corporation is Rios De Avivamiento, Inc., 907 Intracoastal Drive, #9, Fort Lauderdale, FL 33304. The corporation is organized pursuant to **FLORIDA** Nonprofit Corporation Code.

**TWO:** This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation's creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and Social Development programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth at High Risk, Tutorial, Housing, Job Training, Job Placement, Counseling, Employment, Marriage Ceremonies, Burial Services, Youth and Singles Activities Center, Bookstore, Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.

**THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.


**SIX:** The Board of Trustees are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Trustees of this corporation are:

All articles or amendments of the corporation shall be terminated, if at any time be in conflict with the teaching of Jesus Christ. The above articles are in accordance with the 1st and 4th amendments of the U.S. Constitution.
