ARTICLES OF AMENDMENT
TO
DEE ANDREWS MINISTRIES, INC.

The undersigned incorporator, hereby restates and adopts the following Articles of Incorporation in order to meet the guidelines established by the Internal Revenue Code Section 501(c)(3):

ARTICLE I NAME

The name of the corporation shall be: Dee Andrews Ministries, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 4150 Stowe Run Lane, Jacksonville, FL 32225.

ARTICLE III PURPOSES, POWERS, AND ASSETS (AS AMENDED)

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are appointed is: initially, the registered agent will select qualified candidates. There will be three individuals, unrelated to the incorporator, appointed to be in control of the organization.

ARTICLE V REGISTERED AGENT AND STREET ADDRESS

The name and Florida street address of the initial registered agent are: Dee Andrews, 4150 Stowe Run Lane, Jacksonville, FL 32225.
