OF

ARTICLE ONE

Name

The name of the Corporation is COVENANT BRIDE OF CHRIST MINISTRIES, INC.

ARTICLE TWO

Principal Office and Address

ARTICLE THREE

Duration

The term of existence of the corporation is perpetual; and the corporate existence will commence on the filing of these Articles by the Department of State.

ARTICLE FOUR

Purpose

The purpose of this corporation is as follows:

A. An outreach ministry for the teaching, promotion and general furthering of the Gospel of Jesus Christ, as set forth in the Holy Bible, the inspired word of God, by sending and supporting missionaries to other countries, to provide christian counselling for individuals, to hold evangelistic meetings, regular prayer meetings, christian drama and music, and to operate as a regular church.

B. Notwithstanding any other provisions of these articles, the purpose for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the correspondent provision of any future United States Internal Revenue Code.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

To acquire, buy, own, hold, sell, exchange or otherwise dispose of goods, chattels, effects, supplies and merchandise; to mortgage, lease, hypothecate, convey, exchange or dispose of as may be necessary or advisable for the purpose of the , property, both real and personal; to acquire by gift, devise, bequest or otherwise, property, both real and personal, or otherwise and each and every power and right granted to a corporation Not for Profit under the laws of the State of Florida.

E. This corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation and to acquire, through purchase, all of the assets, liabilities, good will, trademarks, and copyrights of Covenant Bride of Christ Ministries, Inc.


