Dear Sirs:

This letter is a plea to reinstate our nonprofit organization with the State of Florida and to please waive the \$175 Reinstatement Fee.

It came to my attention this week that there was no record of receiving the Annual Report filing form and resultantly no \$61.25 fee payment for 2001. Further investigation disclosed that we also had not received or paid any fee to the Department of State for the year 2000.

The probable reason for the Annual Report form not reaching us is that after most of the tornado and fire victims that we served had been moved back into their homes, we moved out of the Salvation Army's building at 700 W. 24th St. in early 2000 (former address on file with you) to a building on the Seminole Community College campus at 100 Weldon Blvd., Building P-64, where we remain today. Some of our mail seemed to take weeks to reach us after the move and it appears the Annual Report form never did.

Per conversation with your Mr. Tyrone on July 13, 2001, we are enclosing our check for both 2000 and 2001's Annual Report plus \$8.75 for a Certificate of Status to serve as a receipt and request that you reinstate our charitable organization without penalty.
