**ARTICLE I  
NAME**

The name of the corporation is **THE JACKSONVILLE CHILDREN'S CHORUS, INC.**

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III  
PURPOSES**

The Jacksonville Children's Chorus, Inc. is a not for profit corporation. The general purpose for which the corporation is formed is to operate exclusively for purposes which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.

The Corporate powers of this corporation are as provided in §617.0302 of the Florida Statutes. The corporation shall not exercise any of its powers for pecuniary profit and shall not perform any function prohibited to corporations not-for-profit by the laws of the State of Florida.

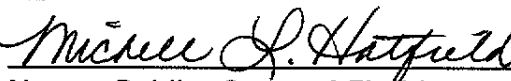

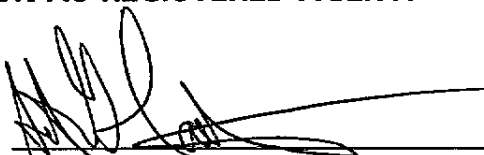
