

ARTICLES OF INCORPORATION
OF
PYRON CHAPEL INDEPENDENT CONGREGATIONAL CHURCH, INC.
A CORPORATION NOT FOR PROFIT

I, the undersigned, with other persons being desirous of forming
corporation for religious purposes do provide as follows:

ARTICLE ONE

The name of the corporation shall be: Pyron Chapel Independent
Congregational Church, Inc., and it is to be located in Okaloosa County, Florida.

ARTICLE TWO

The general nature and object of the corporation shall be to bind together
followers of Jesus Christ for the purpose of sharing in the worship of God and in
making His will dominant in the lives of men, individually and collectively,
especially as that will is set forth in the life and teachings of Jesus Christ; to
exercise Christian care of its members and promote fellowship and mutual
helpfulness among them; to engage in evangelistic, educational and charitable
activities and in efforts for moral and spiritual benefit and improvement of the
community; to promote home and foreign missions and to aid in the spread of the
Gospel of Jesus to the ends of the earth; to educate, prepare, and ordain
Christian men for the ministry of the Gospel of Jesus Christ, to acquire, hold, use,
mortgage, lease, sell, or otherwise encumber and dispose of real and personal
property; and to do all other matters and things whatsoever necessary,

convenient, useful, or incidental to the carrying out of the objects and purposes of the corporation and that are permissible for a non-profit corporation in Florida.

ARTICLE THREE

Any member in full membership of the religious organization known as Pyron Chapel Independent Congregational Church shall also be a member of the corporation. A person ceasing to be a member of said religious organization shall thereupon cease to be a member of the corporation.

ARTICLE FOUR

The corporation shall have perpetual existence.

ARTICLE FIVE

The name and place of residence of the incorporator of these Articles is as follows:

ARTICLE SIX

The governing body of the Church shall be the membership. The method of election of directors shall be provided for in the by-laws.

ARTICLE SEVEN

The following shall serve as officers until the election called for in the By-Laws:

President: David Ball

Vice-President: Dorothy Barnhill

Secretary: Helen Barnhill

ARTICLE EIGHT

These Articles and the by-laws of the corporation shall be adopted by a two-thirds (2/3) favorable vote of the members present at a regular or special meeting. Thereafter, these Articles and the by-laws of the corporation may be made, altered, or rescinded by a two-thirds (2/3) favorable vote of a quorum of the members of the corporation at any regular or special meeting, duly noticed and called for that purpose.

ARTICLE NINE

No person, firm, or corporation shall ever receive any dividends or profits from the undertaking of this corporation; and, upon dissolution of this organization, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified for exemption under Section 501©(3) of the Internal Revenue Code, and none of the assets will be distributed to any member, officer, or director of this corporation.

ARTICLE TEN

The street address of the initial registered and principal office of the corporation is 6498 William Gary Johnson Road, Baker, Florida 32531 and its resident agent for service of process is David Ball, 6498 William Gary Johnson Road, Baker, Florida 32531.
