ARTICLES OF INCORPORATION  
AND DESIGNATION OF REGISTERED AGENT  
OF

ELMWOOD SENIORS MOBILE HOME PARK HOMEOWNERS ASSOCIATION, INC.

A Florida Corporation Not For Profit

The undersigned incorporators, each a natural person, competent to contract, hereby associate themselves to gather to form a corporation not-for-profit under the laws of the state of Florida.

ARTICLE I

The name of the corporation shall be Elmwood Seniors Mobile Home Park Homeowners Association, Inc.

ARTICLE II

The period of the duration of this corporation is perpetual.

ARTICLE III

The principal place of business and mailing address of this corporation shall be 3300 S. Nova Rd. # 35  
Daytona Beach, FL 32119.

ARTICLE IV

The specific purpose(s) for which the corporation is organized is (are):

- (a) For the advancement of the welfare, safety, communications, civic welfare, education, and social enjoyment among the residents of Elmwood Seniors Mobile Home Park 3300 S. Nova Rd. Daytona Beach, FL
- (b) To create a legal entity per Chapter 723.077 as amended, which shall have the power to negotiate for, acquire, operate and maintain the mobile home park, and/or personal property for the members of the association.
- (c) To provide for the conversion of the mobile home community, if acquired, to a cooperative form of ownership.
- (d) To exercise those privileges, powers and duties, as set forth in the "Florida Mobile Home Act" Chapter 723 FS as amended, and to transact any other lawful business permitted by Florida or Federal Statutes and/or laws.

## ARTICLE V

The manner in which the directors are elected or appointed is:

- (a) The board shall consist of no less than three (3) members in good standing. Their number may be increased as determined by the bylaws.
- (b) The directors shall be elected by a majority of the unit membership present at the annual meeting. They shall assume office immediately upon being elected.
- (c) The bylaws may provide for staggered terms of board members.
- (d) The bylaws shall provide for filling a vacant position on the board.
