The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):

The purposes of this non-profit corporation are:

1. Provide with a good, qualified, and low cost medical transportation, which is not for emergency, to the residents of Miami-Dade County.
2. Provide jobs for low income persons.
3. Establish a training program for this type of job.
4. Provide a qualified transportation service for the benefit of the public in general.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

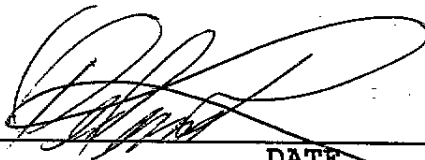
