ARTICLES OF AMENDMENT FOR THE UNITED AUTO GROUP SCHOLARSHIP FUND, INC.

ARTICLE I

The name of the corporation shall be United Auto Group Scholarship Fund, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 3909 N.E. 163rd Street, Suite 304, North Miami Beach, Florida 33160

ARTICLE III

The specific purposes for which the corporation is organized are to provide scholarship funds to students based upon various factors including but not limited to financial need, scholastic achievement, community service, athletic ability, family relationships, leadership qualities and school activity involvement.

The members of the Board of Directors entitled to vote approved these Articles of Amendment of Articles of Incorporation on September 21, 1999, and the three (3) votes cast for the amendment was sufficient for approval.
