ARTICLES OF INCORPORATION

FOR

THE UNDERSIGNED, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is FASP Children's Services Fund, Inc.

ARTICLE II - PLACE OF BUSINESS

The initial principal place of business and the mailing address of this corporation is 617/15/Jillotus Street, Merritt Island, Florida 32952-5234.

ARTICLE III - PURPOSE, MISSION, ACTIVITIES, AND POWERS

- 1. This corporation is formed and the business and the objects to be carried out and promoted by it are to receive and maintain real or personal property, or both, and, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, religious, scientific, or educational purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Service Code and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.
- 2. The mission of this corporation is to advocate for Florida's children, to educate the citizens of Florida about the mental heath and educational needs of Florida's children, and to provide indirect and direct services that promote the educational and psychological well-being of Florida's children. The specific purposes for which the corporation is organized will be:
 - To organize and sponsor fund-raising events to benefit the purposes of the corporation;

- b. To promote and establish partnerships that facilitate the access of children and families to comprehensive educational and psychological services;
- Tō lend assistance through volunteer activities to schools, mental health agencies, and community service organizations;
- d. To educate the citizens of Florida about the educational and psychological needs of children;
- e. To secure financial support through memberships, partnerships, grants, memorials, scholarships, individual or group sponsorships, or other means.
- 3. This corporation will engage in any operation incidental to and essential to carrying out the purposes mentioned above, including but not limited to the following activities:
 - a. Solicit funds and donations in kind from time to time to further the purposes and objects of this corporation;
 - Acquire and receive by purchase, donation, or otherwise, any property, real, personal, or mixed, and to hold, use, and dispose of the same;
 - Borrow money and/or issue evidences of indebtedness to promote any or all of the objects of its business;
 - d. Secure loans by mortgage, pledge, deed of trust, or other lien;
 - e. Make application, obtain, and/or contract with any federal, state, or local government or agency for a direct loan or loans or other financial aid in the form of grants or otherwise relating to the purposes of this corporation; and
 - f. Engage in any kind of activity and enter into, perform, and/or carry out any contracts of any kind that are necessary, connected with, or incidental to the accomplishment of any of the non-profit purposes of the corporation.
- 4. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to any Director or Officer of the corporation, any member of the corporation, or any other private individual, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes. No Director or Officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets or any dissolution of the corporation. No substantial part of the activities of the corporation shall be carrying on propaganda or otherwise attempting to influence legislation,

and the corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office, including but not limited to the publication or distribution of any statement.

- 5. Notwithstanding any other provision of these Articles of Incorporation, this corporation will not carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501 (c) (3) of the Internal Revenue Code and Regulations as they exist now or as they may be amended hereafter.
- 6. Upon the dissolution of the corporation and after paying or making provision for the payment of all of the liabilities of the corporation, the Board of Directors will dispose of all of the assets of the corporation by transfer or donation to any organization or organizations that are organized and operated exclusively for charitable, educational, religious, or scientific purposes and qualified at that time as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code and Regulations or the corresponding provisions of any future United States Internal Revenue law. Any remaining assets will be disposed of by the Circuit Court of Brevard County, Florida or by the Circuit Court of the county in which the principal office of this corporation is then located, exclusively for such purposes or to such organization or organizations which are organized and operated exclusively for such purposes.
- 7. The corporation shall have the powers conferred upon not for profit corporations by Chapter 617, Florida Statutes and any other law or laws of the State of Florida and may exercise those powers in the accomplishment of its objects and purposes. The By-Laws may impose conditions in the exercise of these powers.

ARTICLE IV - DIRECTORS

- 1. The manner in which the Directors of this corporation are elected or appointed shall be determined by the Bylaws of the corporation.
- The number of Directors of this corporation may be altered from time to time as determined under and pursuant to the Bylaws of this corporation. However, this corporation shall have no less than five (5) directors at any time.
