**ARTICLES OF INCORPORATION
OF

We the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida as a corporation not for profit, and hereby adopt the following Articles of Incorporation:

**ARTICLE I- NAME, REGISTERED OFFICE AND PRINCIPAL

ARTICLE VI- AMENDMENTS

Amendments of these Articles of incorporation shall be proposed by resolution adopted by a majority vote of the board of trustees. The resolution shall then be presented to the membership of the corporation. A majority vote of the membership cast at a duly called meeting shall be necessary to amend the Articles of Incorporation.

ARTICLE VII- VOTING

Section 1- Each member in good standing shall be entitled to one vote.

Section 2- Votes may be cast either in person, by proxy or by voting trustee or trustees,, each of whom may, but need not, be an officer or director of the corporation.

ARTICLE VIII- ADDITIONAL PROVISION

Section 1. No officer, director or member shall be personally liable for any debt or other obligation of the corporation.

Section 2. The corporation shall not be operated for profit. No dividend shall be paid, and no part of the income of the corporation shall be distributed to its members, directors or officers.

Section 3. Where the context of these Articles permits, the use of the plural shall include the singular and the singular shall include the plural, and the use of any gender shall be deemed to include all genders.

ARTICLE IX- SEVERABILITY

Should any paragraph, sentence phrase, or portion thereof, of any provision of these Articles or of the Bylaws or rules and regulations be held invalid, it shall or not affect the validity of the remaining parts thereof or of the remaining instruments.

ARTICLE X- APPOINTMENT OF REGISTERED AGENT FOR SERVICE OF PROCESS

Dr. Jesús D. Silva Alamo is appointed registered agent for service of process upon the corporation.

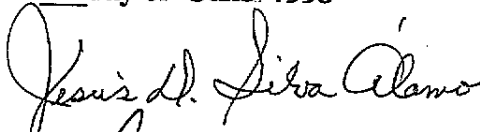

ARTICLE XI - DISTRIBUTION OF ASSETS UPON DISSOLUTION

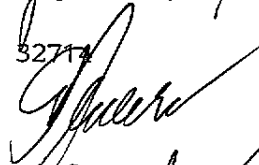
