

Pursuant to the provisions of Sections 617.1002 and 617.006, *Florida Statutes*, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendment adopted:

A portion of Article III, Purpose and Power of the Association is amended; specifically,

The words "(See Exhibit "A" attached hereto)" are deleted and the following provision inserted in its stead:

The land appearing on and included within the plat of Phoenix II Phase One, according the map or plat thereof recorded in Plat Book 109, page 29, public records of Polk County, Florida, LESS AND EXCEPT the areas designated "Acreage Lot 1" and "Acreage Lot 2" appearing on said plat.
