**ARTICLE OF INCORPORATION
JESUS CAN HELP MINISTRY INC.
A corporation not for profit**

We the undersigned, for the purpose of forming a body corporate not for profit under the laws of the State of Florida, do hereby certify, make, subscribe, acknowledge and file in the office of the Secretary of State of Florida, this certificate of incorporation.

ARTICLE I

The name of the corporation shall be Jesus Can Help Ministry, INC. and it shall be a non-profit corporatin under the laws of the State of Florida.

ARTICLE II

The principles office and place of business of the corporation shall be 3420 Schiffko Road, Cantonment ,Florida 32533.

ARTICLE III

- A. The principle of this organization shall be based upon the Bible, the inspired Word of God.
- B. The purpose of this organization shall be to seek and save the lost souls; establish a disciplined study to be come disciples of christ; to promote evangelism and missionary work, both at home and aboard.
- C. This organization shall have the right to license and ordain ministers for the furtherance of the gospel of Jesus Christ.
- D. This organization shall have the right to ordain elders and deacons to oversee the spiritual and practical needs of the body.
- E. This organization shall have the right to own, hold, use, sell, convey, borrow money, mortgage, or otherwise deal in realestate or personal property.

ARTICLE IV

This organization shall be a non-profit religious corporation, without fixed stock or capital.

ARTICLE V

The membership shall consist of those wish to identify with the body and to submit themselves to the authority of the pastor; and who have confessed Jesus as their savior according to Romans 10:8-13. By a godly christian life, each member shall cooperate with the church and it's leaders to attain to a scripture new testament church life.

ARTICLE VI

This corporation shall be established with the provision that the method of election of directors be stated in the bylaws. The bylaws of the corporation shall be adopted at the initial meeting of the corporation to be held at 3420 Schifko Road, Cantonment, Florida, and read into minutes of the meeting. The articles of incorporation may be amended by the director-board at any qualified meeting of the said corporation upon notice that said corporation mya by by-laws provide. The number to trustees may be increased or diminshed from time to time by the by-laws adopted at the first meeting of the corporation. The name of the person who is to serve as initial trustee and president of the corporation is Gregory O. Washington, 3420 Schifko Road, Cantonment, Florida 32533.

ARTICLE VII

- A. The trustees shall hold in trust property titles and deeds for all types of property associated with the organization.**
- B. The trustees shall have general supervision over all business and other affairs pertaining to this corporation and distribution of monies for incurred indebtedness.**
- C. The charter pastor shall be a lifetime trustee and president of the corporation.**
- D. Trustees shall be owners of property other than personal property.**
- E. Neither trustee nor members shall be personally liable for debts or obligations of this corporation.**

ARTICLE VIII

In order to accomplish it's objectives, the corporation shall have the general powers of a Florida corporation not for profit, including each of those general powers enumerated under Florida statute 607.011 chapter 617 and chapter 91-208, laws of Florida. To perpetually protect this local church organization in its ownership and control of its property and in this sovereignty under christ, all ecclesiastical power and authority relative to this church shall be exericsed by the pastor and appointees, and all authority relative to its buildings and land shall be exericsed by this title church and the decisions title made are not subject to reversal or amendment by other ecclesiastical body whatsoever.

ARTICLE IX

The registered office of the corporation shall be 3420 Schifko Road, Cantonment, Florida 32533. The registered agent shall be Gregory O. Washington, 3420 Schifko Road, Cantonment, Florida, 32533.

ARTICLE X

The name and address of this incorporator of this corporation is Gregory O. Washington, Cantonment, Florida 32533.


