## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt (s) the following Articles of Incorporation:*

### ARTICLE I NAME

**SOUTH BREVARD COMMUNITY DEVELOPMENT CENTER, INC.**

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE

South Brevard Community Development Center is organized to provide wholistic community outreach services to economically disadvantaged individual and families within the high risk communities in the crime ridden areas of South Brevard County. Service provision is designed to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. SBCDC services will consist of but not be limited to job readiness and placement, land acquisition and housing; employment, literacy, counseling, temporary shelter; teenage pregnancy prevention education; substance abuse awareness and prevention; tutoring, HIV prevention education; elderly care referral services and other programs to aid those in need.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall be no less than three (3) in number and serve the organization during their three year term as long as their duty is performed consistent with the organization's By-laws but may resign at any time or be removed with or without cause by a majority vote of the Board of Directors. Any resignation or removal shall be in writing and shall become a part of the records of the organization. Directors are appointed after nominations and recommendations are officially submitted in writing to the Board. After a review and discussion by the majority of the Board of Directors of the nominations and recommendations received, the appointments are made by the Board majority.


