*The undersigned incorporator, for the purpose of forming a corporation under the Florida
Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.*

ARTICLE I

The name of the corporation shall be Assisting Communities for Accomplishment, Inc.

ARTICLE II

It's principal place of business and office in the state of Florida is to be located in the county of Palm Beach and branch offices may be established in such places in the state of Florida, in the United States as may from time to time be authorized by the Board of Directors. The registered office of the corporation will begin at: 4260 Canal 8 Rd, West Palm Beach, Florida 33406 and is subject to change in the future.

ARTICLE III

The purposes of the corporation are defined under Social Services and plan to help provide housing and programs for families and youth at risk in surrounding communities of Palm Beach County, Florida.

ARTICLE IV

The number of directors shall not be less then three.

ARTICLE V


The registered agent for this corporation is Rochelle Massinello and the address will begin location at: 4260 Canal 8 Road, West Palm Beach, Florida 33406.

Additional Articles to be adopted to the undersigned incorporator :

ARTICLE VII


No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to it's members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article VII, herefor. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

ARTICLE VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization, as said Court shall determine, which are organized and operated exclusively for such purposes.


