ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statues, adopt(s) the following articles of Incorporation:

ARTICLE I

The name of the Corporation shall be: Against Da Grain Ministries, Inc.

ARTICLE II

The principal place of business of this corporation shall be: Tallahassee, Florida. The mailing address of this corporation shall be:

ARTICLE III

The specific purpose(s) for which the corporation is (are):
Against Da Grain Ministries, Inc. is specifically a non-profit independent Christian
Ministry, with the purpose of spreading the gospel of the Lord Jesus Christ throughout as
much of the world as possible. This corporation will engage in making, teaching and
leading disciples into the family of Almighty God.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

The President of the Corporation shall remain in office for as long as his/her physical and mental abilities will allow. Other officers and/or directors shall be appointed as needed by the leadership. Expansion of Article IV can be found in corporation by-laws.

ARTICLE V

The President of the corporation shall be responsible for managing affairs of the corporation. By-laws of the corporation are to be made by the President of the corporation with the assistance of other board members. Board members shall consist of persons elected and/or appointed from the membership at the discretion of the President. Board members may also include honorary persons not a part of the membership at the discretion of the President. Any such by-laws will be introduced for law to those corporation members present at any such called business meeting. Proposed by-laws shall be altered, rescinded or voted into law by a majority vote of those members present at any such called business meeting in which by-laws are to be made, altered, and or rescinded. Amendments to the Articles of Incorporation may be proposed by the President or any member upon approval of the President, after which said amendments

are to be introduced to the body of members and adopted by a majority vote of members present at any such business meeting wherein amendments to the Articles of Incorporation are to be proposed and/or adopted.

ARTICLE VI

The registered agent shall be the President and founder of the Corporation; Cainon Renard Lamb. The registered office is:

The seven above named persons will constitute the initial official board of directors/trustees. These persons shall serve as members of the board of directors/trustees.

- 2. Any person who has been spiritually "born again," through faith in Jesus Christ as Lord and Savior, is qualified to become a member of this organization provided they show genuine evidence of godly character. Persons shall be accepted in any of the following ways:
 - (1) Baptism into the body of Christ and/or Christian experience and or letter of church membership.
 - (2) Any person who has been received as a member of this Christian organization has the right and privilege to participate in all activities and voting rights that pertains to the members.
 - (3) Participation in a lifestyle contrary to the principles of God as stated in the Bible, God's Holy Word, is reason enough for dismissal or expulsion from

this body until such time as the disobedient life has been reconciled to the perfect will of God and thereby restored to sweet fellowship.

- (4) Members shall be free to transfer or relinquish their membership at their discretion.
- (5) In the event of dissolution the residual asset of the corporation, Against Da Grain Ministries, Inc. will be turned over to The Spirit of Christ Center and Ministries Church, Miami, Florida which themselves are exempt as an organization as described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue code of 1954 or Corresponding Sections of any prior future of the Internal Revenue code, or to the Federal, State, or Local Government for exclusive public purpose. However, if the named recipient is not then in existence or no longer a qualified distributee, or unwilling to accept the distribution, then the assets of this corporation shall be distributed to a fund, foundation or corporation organized and operated exclusively for the purposes specified in Section 501 (c) (3) of the Internal Revenue Code (or corresponding of any future Federal tax code).

Notwithstanding any provisions of these articles, this corporation shall not carry on any other activities not permitted to be carried on by:

- (a) a corporation exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Law, or
- (b) a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal revenue Law.
- (6) There will be no limitations created because of divisions established by classes of people. All shall be ranked as established by the oracle Word of God. All members shall be obligated first by God, then to follow members, to walk circumspectly in the world. All members will walk worthy of the vocation of the calling to be sons and daughters of the Most High God; spreading themselves from involvement in the lust of the world.
