

**ARTICLES OF INCORPORATION  
OF  
CHRIST WORLD MINISTRIES, INC.**

The undersigned incorporator, to form a corporation not for profit for religious, charitable, benevolent, educational and literary purposes, does hereby adopt the following Articles of Incorporation.

**ARTICLE I**

**NAME**

**EFFECTIVE DATE**

8-31-98

The name of the Corporation shall be Christ World Ministries, Inc.

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be 112 South Magnolia Avenue, Tampa, Florida, 33606, Hillsborough County. However, the Corporation shall have the power to relocate its principal office, or to establish branch offices, at other places within the State of Florida as may be determined expedient.

**ARTICLE III**

**PURPOSE**

The specific purposes for which this Corporation is organized are:

(a) To promote the religious beliefs and works of the Church of Jesus Christ as disclosed in the New Testament.

(b) To offer its services to local congregations, mission fellowships, Christian higher education and publications, and to needy individuals.

(c) To engage in all activities and endeavors, consistent with its Christian foundation, as permissible under Chapter 617, Florida Statutes and applicable laws of Florida, including but not limited to, investing its funds in real or personal property, mortgages, stocks, bonds, debentures, making contracts and incurring liabilities, in any state, territory or possession of the United States and any foreign country.

#### ARTICLE IV

##### **BOARD AND ELECTION OF DIRECTORS**

(a) The number of directors constituting the initial Board of Directors shall be three (3). The number of directors may be increased or decreased in accordance with the By-Laws, but shall never be less than three (3).

(b) All directors shall be elected by majority vote of the voting members of the congregation. A director shall be elected for a term of four (4) years, and may serve more than one (1) term.

(c) Subject to limitations imposed by the By-Laws, all activities of this church-corporation shall be governed by the Board of Directors.

#### ARTICLE V

##### **INITIAL REGISTERED AGENT AND STREET ADDRESS**

**EFFECTIVE DATE**


The effective date of these Articles of Incorporation shall be five (5) business days prior to the date of receipt by the Department of State.

**ARTICLE VIII**

**AMENDMENTS TO ARTICLES OF INCORPORATION**

The voting members of this church-corporation shall have the authority by sixty percent (60%) affirmative vote to adopt, alter, amend or repeal any provision of these Articles of Incorporation.
