
**ARTICLES OF INCORPORATION

ONE: The name and address of this principal corporation is Faithful Deliverance Temple, Inc., 13660 N.W. 2nd Avenue, Miami, Florida 33023, in Dade County, Florida. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This Corporation is a nonprofit corporation. The corporation is organized to operate as a church and religious entity.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
