The undersigned, acting as incorporator(s) for the purpose of forming a not for profit corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be **NORTH PARK PIONEERS CIVIC ASSOCIATION, INC.**

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III

The specific purposes for which the corporation is organized are:

- To foster, promote and protect the civic and community interests of the residents of Lauderdale North Park 5 (also known as LNP-5) section of the City of North Lauderdale.
- To represent the neighborhood to the City of North Lauderdale and to all its departments and other governing agencies.


