- (2) To eliminate trade abuses and establish a firm confidence between sellers and buyers of all sales food store representatives and executives and the members of this corporation.
- (3) To promote uniformity and certainty in business customers and practices and encourage the interchange of ideas between sales, wholesale and retail representatives and exexcutives.
- (4) To cause sales and manufacturers representatives to be regarded with the esteem they deserve in the business by virtue of the unique and valuable service they render to the manufacturer, the distributors and the public at large.
