The undersigned subscribers to these Articles of Incorporation do hereby associate themselves for the purpose of becoming a corporation under the laws of the State of Florida.

**ARTICLE I.**

The name of this corporation shall be **ANTIOCH MISSIONARY BAPTIST CHURCH OF QUINCY, FLORIDA, INC.**, a Florida corporation.

**ARTICLE II.**

The principal place of business and mailing address of this corporation shall be 1003 West Clark Street, Quincy, Florida 32351.

**ARTICLE III.**

The specific purpose for which this corporation is organized is to advance Kingdom of God consistent with the Holy Bible in the tradition of the Missionary Baptist Church and to procure for the benefit of its members the blessing of membership through preaching, instruction, evangelism and the worship of Almighty God.






ARTICLE VII.
