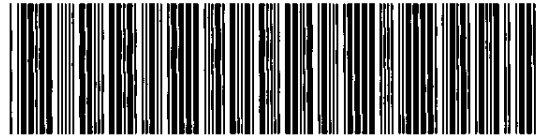

**AMENDED ARTICLES OF INCORPORATION  
OF  
ANTIOCH MISSIONARY BAPTIST CHURCH OF QUINCY, FLORIDA, INC.**

The undersigned subscribers to these Amended Articles of Incorporation do hereby associate themselves for the purpose of becoming a corporation under the laws of the State of Florida.

**Article I.**

The name of this corporation shall be ANTIOCH MISSIONARY BAPTIST CHURCH OF QUINCY, FLORIDA, INC., a Florida corporation.

**Article II.**

The principal place of business and mailing address of this corporation shall be 1003 West Clark Street, Quincy, Florida, 32351.

**Article III.**

The specific purpose for which this corporation is organized is to advance the Kingdom of God consistent with the Holy Bible in the tradition of the Missionary Baptist Church and to procure for the benefit of its members the blessing of membership through preaching, instruction, evangelism, and the worship of Almighty God.

**Article IV.**

The manner in which **TRUSTEES** are elected shall be as follows:

Three (3) trustees shall serve as the only legal representatives of the Church and shall serve annual terms, or until they are relieved by their successors. Successors are to be elected by a majority of the Trustees and Deacon Boards combined, but only if at least two (2) trustees and a majority of the Deacon Board are present for any such meeting held for the election of trustees after at least fourteen (14) days notice of the election has been given to the Church's congregation.


**CERTIFICATE OF DESIGNATION OF
