ARTICLES OF INCORPORATION  
OF  
WEWAHITCHKA PEEWEE FOOTBALL LEAGUE, Inc.  
A NON PROFIT ORGANIZATION

ARTICLE I - NAME

The name of the organization is WEWAHITCHKA PEEWEE FOOTBALL LEAGUE, Inc. and is located at 215 Lucy Drive, Wewahitchka, Florida, and whose mailing address is P. O. Box 1667, Wewahitchka, Florida, 32465.

ARTICLE II - DURATION

This organization shall exist for a period of fifty (50) years commencing on the date of execution and acknowledgment of these articles, unless dissolved earlier. The organization will be subordinate to and subject to the authority of the league. Upon dissolution, any assets of the organization shall be distributed to the Wewahitchka High School Athletic Fund.

ARTICLE III - PURPOSES

The purpose of WEWAHITCHKA PEEWEE FOOTBALL LEAGUE, Inc. is to promote athletics and sportsmanship among youth ages six through twelve.

ARTICLE IV - CAPITAL STOCK

There shall be no stock issued, however, the Directors may vote to apply to the Internal Revenue Service for a tax free number.

#### ARTICLE V - VOTING

Members of the organization shall be adults who have a child enrolled in the program. Directors will be elected, after the first year, on the night of the annual awards banquet by one parent of each Pee Wee Football player who is actively participating .

#### ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

#### ARTICLE VII - INITIAL BOARD OF DIRECTORS AND OFFICERS

#### ARTICLE IX - BYLAWS

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

#### ARTICLE X - DIRECTOR QUORUM AND VOTING

A majority of the directors shall constitute a quorum for a meeting of directors. If a quorum is present, the affirmative vote of a majority of the directors present, or, if a director or directors have abstained from voting because of an interest in the matter to be voted upon, the affirmative of all of the remaining directors, shall be the act of the Board of Directors.

ARTICLE XI - MEETING BY CONFERENCE TELEPHONE

Members of the Board of Directors may participate in meetings of the Board of Directors by means of conference telephone as provided by law.

XII - ACTION BY DIRECTORS WITHOUT A MEETING

The Directors of this corporation may take action by written consent, as provided by law.

ARTICLE XIII - INDEMNIFICATION

The corporation shall not indemnify any officer or director or any former officer or director, except for out of pocket expenses, to the full extent permitted by law.

ARTICLE XIV

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendments hereto.

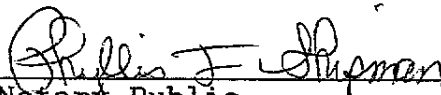

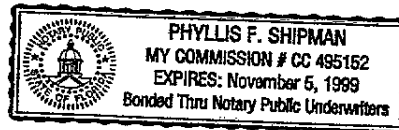

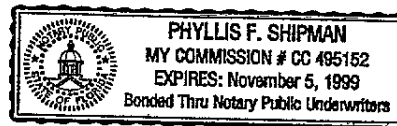
