WE, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the Laws of the State of Florida., under provisions of chapter 617.

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be-----

JOSHUA Corporation.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The initial street address in this state of the principal office of this corporation is 6509 Secrest Court, Tampa, Hillsborough County, Florida. The Board of Directors may, from time to time, move the principal office to any other address in the United States and the State of Florida.

ARTICLE III - NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is GENERAL POWERS, and any other activities or business permitted under the laws of the United States and the State of Florida.

To conduct business in, missionary, religious publishing, and other religious activities, and to conduct activities in, student loans, ther student aid, student housing, student operated business, study and research, rural medical facility, hospital, rescue and emergency service, aid to the handicapped, scientific research, other medical research, other health services, other scientific research, research development and testing, financing crop operations, other farming and related activities, fundraising athletic or sports event, prevention of cruelty to children, conservation environmental and beautification, low and moderate income housing, other housing activities, crime prevention, defense of human and civil rights, prohibition of erotica, sex education in schools, other matters, providing bail, other legal aid, supplying money goods and/or services to the poor, gifts or grants to individuals, other loans to individuals, gifts grants or loans to other organizations, emergency or disaster aid fund, advertising, fundraising, and domestic organization with activities outside U.S.

ARTICLE IV - DIRECTORS

This corporation shall have one director initially. The number of directors may be increased or diminished from time to time, by by-laws adopted by the directors and officers. THE ELECTION OF DIRECTORS WILL BE SET FORTH IN THE BY-LAWS.

ARTICLE V - REGISTERED AGENT

The initial designation of the registered office of this Corporation shall be: 6509 Secrest Court, Tamp, Hillsborough County, Florida 33625.
