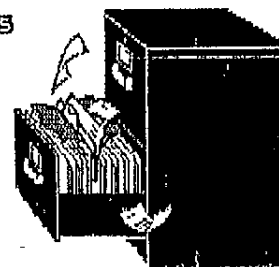

ARTICLES OF INCORPORATION

We, the undersigned subscribers, all being of full age, have associated ourselves together for the purpose of forming a corporation not-for-profit, without capital stock, under the provisions of all applicable State of Florida Statutes. We hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law, and we do hereby, subscribe, acknowledge and file these Articles of Incorporation.

ARTICLE I

NAME: DELIVERANCE COMMUNITY INVOLVEMENT CORPORATION

ARTICLE II

PURPOSE: To provide service, training, tutoring, guidance and whatever other social service necessary to promote individual responsibilities of all participants. Services offered to all low income and underprivileged persons including present welfare and other governmental social program(s) aimed at helping the unfortunate. Assign qualified personnel to perform tasks of enhancing the living standards and conditions for the single family parent and others that require the educational skills /technical abilities to adequately provide for their children. Moreover we will establish a learning resource (library) center, designed to aid those who need to develop good reading, speech, computer, literacy and other skills. Provide a recreational facility, to promote a healthy environment for our youngsters aimed at preventing crime, alcohol and drug abuse. Promote ethical and moral standards, develop a sense of unity among neighbors.

ARTICLE III

TERM OF EXISTENCE: The term of existence of this corporation is perpetual.

ARTICLE IV

OFFICERS AND MANAGEMENT: The officers of this not-for-profit corporation shall be a President, Vice-President, Secretary, Treasurer, Financial Secretary. Management shall be vested in a board of directors; consisting of at least seven (7) and no more than twenty five (25) . Directors shall be chosen from the membership of Deliverance Church Of God In Christ, and other community development minded persons.

ARTICLE V

SUBSCRIBERS, INITIAL OFFICERS: The subscribers, initial officers are to serve until the first election under these Articles of Incorporation are as follows;

ARTICLE VI

BY-LAWS: The By-Laws of the corporation shall be made, altered or rescinded by a majority vote of the board of directors; provided that notice thereof, which shall include the text of the By-Laws change, has been furnished in writing to each member of the board at least ten (10) days prior to the meeting at which such By-Law alteration is to be voted upon. Directors shall be elected or appointed in accordance with the By-Laws.

THIS CORPORATION SHALL BE A SUBSIDIARY OF DELIVERANCE CHURCH OF GOD IN CHRIST.

The Articles of incorporation of this corporation shall be amended or additional provisions adopted by a two-thirds (2/3) vote of the members of the board of directors present. Provided that notice thereof, which shall include the text of the Articles of Incorporation change is to be voted upon, followed by the compliance with the Florida Statutes regarding amendments to Articles of Incorporation of corporations Not-For-Profit.

ARTICLE VII

GENERAL: Funding for this corporation will be from various sources, to include grants from government agencies, and other charitable groups. Tax exempt status will be obtained from Internal Revenue Service in accordance with 501(c)(3) statute.

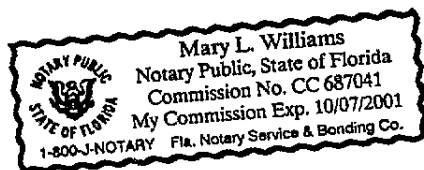
