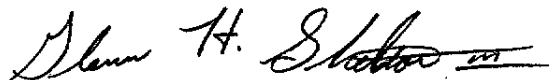

**Articles of Incorporation
Of

Article I: The Name of Corporation

The Name of the corporation shall be Global Community Network, Inc.

Article II: Principal Place of Business

Global Community Network, Inc. shall be located at 621 Georgia Avenue, St. Cloud, FL 34769.

Article III: The Specific Purpose

Global Community Network, Inc. is being established for the purpose of providing education to persons, whether male, female, adult or child, through the use of technology, computers and Internet access. Furthermore the corporation shall introduce Internet access into homes with computers and supply a location for use by those who live in homes without access to a computer. Also the corporation shall use donated equipment to supply, by loan, qualifying homes with the needed hardware to gain access to our services from home. The corporation shall be registered with the Internal Revenue Service under section 501(c) 3, as amended, and shall not conduct any business outside of the codes stated therein.

Article IV: Manner of Director Appointment

Within 90 days of filing with the State of Florida, four (4) officers/^{directors} will be appointed by majority vote at the address of the Incorporation, as stated in the bylaws.

Article V: Membership/ Board of Directors

The corporation shall have no members. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

The number of Directors constituting the first Board of Directors is seven (7), their names and addresses being as follows:

Members of the first Board of Directors shall serve until the first annual meeting, at which their successors are duly elected and qualified, or removed as provided in the bylaws.

Article VI: Intended Duration of Corporation

It is the intent of the incorporators of Global Community Network, Inc. for the duration of the corporation to last no less than infinitely.

Article VII: Personal Liability

No Board member or Director of the corporation shall hold personal liability of any nature for any debt or obligation. Furthermore no property belonging to any Board member or Director may be subject to the payment of any debts or obligations of the corporation.

Any and all budgets are subject to the acceptance of the Board of Directors. The budget and all expenditures must be in written form and a copy presented to each Board Member in a manner as stated in the bylaws. No Major changes may be made to the budget without approval of the board by a majority decision. The corporation shall have its fiscal year run from October 1st through September 30th. An annual report is required, and shall be presented to the board, showing income, expenditures, and pending income. All financial records kept for the corporation shall be held as public information and will be available to both the Board and the public at request.

Article VIII: Amendments

The corporate bylaws may be amended whenever necessary by a majority of the Board of Directors. Any additions or changes to these bylaws must be presented in writing to the Secretary to be submitted to the Members of the Board.

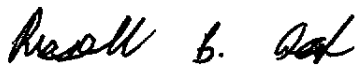

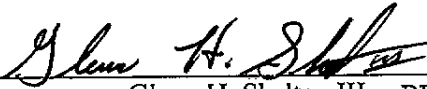

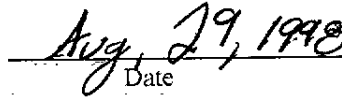
