ARTICLES OF INCORPORATION FOR DOWN SYNDROME ASSOCIATION OF POLK COUNTY, INC. A FLORIDA NOT-FOR PROFIT CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1 NAME

The name of this corporation shall be:
"Down Syndrome Association of Polk County, Inc."

ARTICLE 2 PRINCIPAL OFFICE

The principal place of business of this corporation is: 2815 Oakland Ave.

Lakeland, FL 33803

The mailing address of this corporation is: 2815 Oakland, Ave. Lakeland, FL 33803



ARTICLE 3 PURPOSE

The purposes for which the corporation is organized are as follows:

- a) This corporation is organized and operated exclusively for religious, charitable, scientific and educational purposes, including the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code as currently in effect, as subsequently amended, or corresponding section of a future federal tax code.
- b) The corporation shall restrict its operations to the promotion of religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Code. The corporation shall take no action inconsistent with the Provisions of the Florida Not For Profit Corporation Act.

c) No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, directors, officers or other private persons, except that the corporation is empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

ARTICLE 4 MANNER OF ELECTION OF DIRECTORS

The affairs of this corporation shall be managed and directed by a Board of Directors. The manner in which directors are elected shall be as set forth in the Bylaws of this corporation. There shall at all times be at least 3 directors. The initial board of directors shall consist of the following:

ARTICLE 7 DISSOLUTION

Notwithstanding any other provisions of these Articles, upon dissolution of the corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code as currently in effect, as subsequently amended, or corresponding section of a future federal tax code, or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
