The undersigned incorporator by these articles associates himself for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopts the following articles of incorporation:

#### ARTICLE 1. NAME

The name of this corporation is THE OLD SPANISH TRAIL SADDLE CLUB OF SANTA ROSA COUNTY, INC. For convenience, the corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," and the Bylaws of the association as the "Bylaws."

#### ARTICLE 2, TERM OF EXISTENCE

The Association shall have perpetual existence.

#### ARTICLE 3. PURPOSE

This Association is organized for the purpose of promoting interest in horses and horsemanship and to provide facilities for a drug and alcohol free environment for families of the area to enjoy equine sports and related activities, and for any and all other lawful purposes.

#### ARTICLE 4. MEMBERS

Membership is open to any person who pays the dues as required by the Bylaws of the Association and who abides by the Bylaws and published Rules & Regulations of the Association.

### ARTICLE 5. INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial Registered Agent of this corporation is 3876 Fox Road, Milton, Florida, 32571, and the name of the initial Registered Agent of this corporation at that address is Gene R. Miller, Sr. The principal office shall be 3876 Fox Road, Milton, Florida, 32571.

#### ARTICLE 6. DIRECTORS

Number and Qualifications. The property, business and affairs of the Association shall be managed by a board of directors. The number of directors shall be determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) directors.

The affairs of the Association shall be administered by the officers holding the offices designated in the By-Laws. The officers shall be elected by the Board of Directors of the Association at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors. The By-Laws may provide for the removal from office of officers, for filling vacancies and for the duties and qualification of the officers.
