ARTICLES OF INCORPORATION OF
PINELLAS CHEER ELITE CHEERLEADER AND
DANCE ASSOCIATION, INC

ARTICLE ONE

NAME

THE NAME OF THE CORPORATION SHALL BE THE PINELLAS CHEER
ELITE CHEERLEADER AND DANCE ASSOCIATION INC AND IS FORMED
PURSUANT TO FLORIDA STATUTES CHAPTER 617.

ARTICLE TWO

DURATION

THE TERM OF EXISTENCE OF THE CORPORATION SHALL BE
PERPETUAL UNLESS SOONER TERMINATED AS PROVIDED FOR BY LAW.

ARTICLE THREE

PURPOSE

THE CORPORATION IS ORGANIZED AS AN EDUCATIONAL ATHLETIC
ORGANIZATION, SPECIFICALLY FOR THE FOLLOWING CHARITABLE
PURPOSES:

- (a) TO EDUCATE AND INSPIRE YOUTH, REGARDLESS OF RACE,
CREED, COLOR, OR NATIONAL ORIGIN, TO PRACTICE THE IDEALS OF
SPORTSMANSHIP, FELLOWSHIP, AND PHYSICAL FITNESS LOCALLY,
NATIONALLY AND INTERNATIONALLY.
- (b) TO EDUCATE, PROMOTE AND FOSTER, LOCAL, NATIONAL,
AND/OR INTERNATIONAL ATHLETIC COMPETITION, IN PARTICULAR
CHEERLEADING, (HOWEVER NO PART OF THE CORPORATION'S ACTIVITIES
SHALL INVOLVE THE PROVISION OF ATHLETIC FACILITIES OR EQUIPMENT).
- (c) FOR SUCH OTHER CHARITABLE PURPOSE(S) AND TO BE
OPERATED FOR THE PURPOSE(S) AS SET OUT IN THE INTERNAL REVENUE
CODE SECTION 501 (c) (3).

ARTICLE NINE


DISTRIBUTION OF EARNINGS


NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTED TO ITS MEMBERS, TRUSTEES, OFFICERS, OR TO OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PROVISIONS OF ARTICLE THREE ABOVE. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION AND THE CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN, (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON : (a) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(c) (3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (b) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER 170 (c) (2) OF THE INTERNAL REVENUE CODE, OR SECTION OF ANY FUTURE FEDERAL TAX CODE.




DISSOLUTION OF THE CORPORATION

ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF PINELLAS COUNTY, FLORIDA, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION(S) AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.

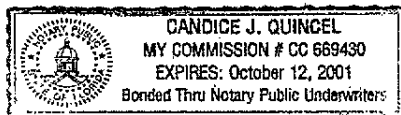
