

THE MAJOR PROGRAM ACTIVITIES WILL INCLUDE A PROGRAM TO HELP HOMELESS GET BACK INTO THE "MAINSTREAM", WHICH WILL PROVIDE TEMPORARY SHELTER, FOOD AND CLOTHING UNTIL THEY GET EMPLOYMENT AND ENOUGH MONEY TO GET THEIR OWN APT.

WE WILL ALSO BE WORKING WITH VICTIMS OF DOMESTIC VIOLENCE WITH INCREASED PUBLIC AWARENESS, MONETARY ASSISTANCE,

AND MATERIAL HELP. THIS WILL INCLUDE FOOD, CLOTHING, SHEETS TOWELS, BLANKETS, DIAPERS, FORMULA ETC.. TO LOCAL SHELTERS AND INDIVIDUALS IN NEED.

WE ALSO LOOK TO HELP RUNAWAYS GET BACK HOME BY PROVIDING FREE TRANSPORTATION TO THOSE WHO WANT TO RETURN. THIS PROGRAM WILL ALSO PROVIDE ASSISTANCE TO OTHER AGENCIES THAT WORK WITH RUNAWAYS.

THESE ARE THE FIRST AND PROBABLY THE MOST BASIC PROGRAMS THAT WE WILL BE WORKING ON BUT WE WILL ALWAYS REMAIN OPEN TO HELP ANY GROUP OF PEOPLE WHO CAN USE SOME TEMPORARY HELP.
