ARTICLES OF INCORPORATION

LAS BRISAS AT DORAL COMMUNITY ASSOCIATION, INC. (A CORPORATION NOT FOR PROFIT)

In compliance with the requirements of the Laws of the State of Florida, and for the purpose of forming a corporation not for profit, the undersigned does hereby acknowledge:

- Name of Corporation. The name of the corporation is LAS BRISAS AT DORAL COMMUNITY ASSOCIATION, INC. ("Association").
- Principal Office. The principal office of Association is 7200 N.W. 7th Street, Suite 300, Miami, Florida 33126 or such other location as designated by the Board of Directors of the Association.
- Registered Office Registered Agent. The street address of the Registered Office of Association is 20801 Biscayne Boulevard, suite 501, Aventura, Florida 33180. The name of the Registered Agent of Association is:

- Definitions. A declaration entitled Declaration of Restrictions and Covenants for Las Brisas at Doral Community (the "Decistation") will be recorded in the Public Records of Miami-Dade County, Florida, and shall govern all of the operations of a community to be known as Las Brisas at Doral Community. All initially capitalized terms not defined hexein shall have the meanings set forth in the Declaration.
- Purpose of Association. Association is formed to: (a) provide for ownership, operation, maintenance and preservation of the Common Areas, and improvements thereon, including without limitation the Surface Water Management System; (b) perform the duties delegated to it in the Declaration; (c) administer the interests of Association and the Owners; and (d) promote the health, safety and welfare of the Owners.
- Not for Profit. Association is a not for profit Florida corporation and does not contemplate pecuniary gain to, or profit for, its members, Board of Directors or officers.
- Powers of Association. Association shall, subject to the limitations and reservations set forth in the Declaration, have all the powers, privileges and duties reasonably necessary to discharge its obligations, including, but not limited to, the following:
- To perform all the duties and obligations of Association set forth in the Declaration, these Articles, 7.1
- To enforce, by legal action or otherwise, the provisions of the Declaration, these Articles, and the and the By-Laws. By-Laws and the rules, regulations, covenants, restrictions and/or agreements governing or binding Association.
- To fix, levy, collect and enforce payment, by any lawful means, of all Assessments payable pursuant to the terms of the Declaration, these Articles, and the By-Laws.
- To pay all Operating Costs, including, but not limited to, all licenses, taxes or governmental charges levied or imposed against the Common Area or other property of Association, and establish reserves for deferred maintenance or capital expendinues.
- To acquire (by gift, purchase, or otherwise), annex, own, hold, improve, build upon, operate, maintain, convey, grant rights and easements, sell, dedicate, lease, transfer or otherwise dispose of real or personal property (including but not limited to the Common Areas) in connection with the functions of Association except as limited by the Declaration.

- To borrow money, and to mortgage, pledge or hypothecate any or all of its real or personal property as security for money or debts incurred.
- To operate and maintain the Surface Water Management System in accordance with any and all permits for such system issued by SFWMD or its successor.
- To dedicate, grant, license, lease, concession, create easements upon, sell or transfer all or any part of, the Common Areas to any public agency, entity, authority, utility or other person or entity for such purposes and subject to such conditions as it determines subject only to requirements in the Declaration, if any.
- 7.9 To participate in mergers and consolidations with other non-profit corporations organized for the same purposes.
- 7.10 To adopt, publish, promulgate or enforce rules, regulations, covenants, restrictions or agreements governing Association, the Common Areas, Parcels and Homes as provided in the Declaration and to effectuate all of the purposes for which Association is organized.
- 7.11 To have and to exercise any and all powers, rights and privileges which a not-for-profit corporation organized under the Laws of the State of Florida may now, or hereafter, have or exercise.
- 7.12 To employ personnel and retain independent contractors to contract for management of Association and the Common Areas as provided in the Declaration and to delegate in such contract all or any part of the powers and
- 7.13 To contract for services to be provided to, or for the benefit of, Association, Owners, and the Common duties of Association. Areas as provided in the Declaration such as, but not limited to, Telecommunication Services, maintenance, garbage pick-up, utility services, and services necessary to maintain the Surface Water Management System..
 - 7.14 To establish committees and delegate certain of its functions to those committees.
- 7.15 To hold all funds and property owned and acquired by the Association in the name of the Association for the benefit of Members in accordance with the provisions of the Declaration, these Articles, and the By-Laws.
- Voting Rights. Owners and Developer shall have the voting rights set forth in the Declaration and the By-Laws. All Owners subject to assessments, including contract sellers, shall be members of Association.
- Board of Directors. The affairs of Association shall be managed by a Board of odd number with not less than three (3) nor more than five (5) members. The initial number of directors shall be three (3). Board members shall be appointed and/or elected as stated in the By-Laws. The election of Directors shall be held at the annual meeting of the members. Directors shall be elected for a term expiring on the date of the next Annual Members Meeting. - Dissolution. In the event of the dissolution of Association other than incident to a merger or consolidation. (I) any member may petition the Circuit Court of the Judicial Circuit of the State of Florida having jurisdiction for the appointment of a receiver to manage the affairs of the dissolved Association and to manage the Common Areas, in the place and stead of Association, and to make such provisions as may be necessary for the continued management of the affairs of the dissolved Association and its properties and (ii) the Surface Water Management System shall either be dedicated to an appropriate agency of local government or to a non-profit corporation of similar nature to Association to assure perpental maintenance thereof.
- Duration. Association shall have perpetual existence. 11
- Amendments. 12
- General Restrictions on Amendments. Notwithstanding any other provision herein to the contrary, no amendment to these Articles shall affect the rights of Developer unless such amendment receives the prior written consent of Developer, which may be withheld for any reason whatsoever. No amendment shall be effective until it is recorded in the Public Records.
- Amendments Prior to the Community Completion Date. Prior to the Community Completion Date, Developer shall have the right to amend these Articles as it deems appropriate, without the joinder or consent of any person or entity whatsoever. Developer's right to amend under this Section is to be construed as broadly as possible. In the event that Association shall desire to amend these Articles prior to the Community Completion Date, Association must first obtain Developer's prior written consent to any proposed amendment. Thereafter, an amendment identical to that approved by Developer may be adopted by Association pursuant to the requirements for amendments from and after the Community Completion Date. Thereafter, Developer shall join in such identical amendment so that its consent to the same will be reflected in the Public Records.
- Amendments From and After the Community Completion Date. After the Community Completion Date, but subject to the general restrictions on amendments set forth above, these Articles may be amended with the approval of two-thirds (66 2/3%) of the Board.
- Limitations. 13
- Declaration is Paramount. No amendment may be made to these Articles which shall in any manner reduce, amend, affect or modify the terms, conditions, provisions, rights and obligations set forth in the Declaration.
- Rights of Developer. There shall be no amendment to these Articles which shall abridge, reduce, 13.2 amend, effect or modify the rights of Developer.
 - By-Laws. These Articles shall not be amended in a manner that conflicts with the By-Laws. 13.3

No Director or Officer of Association shall incur liability by reason of the fact that such Director or Officer may be interested in any such contract or transaction. Interested Directors shall disclose the general nature of their interest and may be counted in determining the presence of a quorum
