Revenue Law.

(b) Article VII DISSOLUTION	
Add new article- In the event of dissolution, the residual	
assets of the organization will be turned over to one or more organizations which themselves are exempt	
as organizations described in 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or the	
corresponding provision of any prior or future Internal Revenue Code, or to the Federal, State, or local	
government for exclusive public purpose.
