The undersigned, for the purpose of forming a non-profit corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE:

The name of the non-profit corporation is NATIONAL CHALLENGED SOCIETY, INC. The principal office and mailing address shall be 315 W. Pennsylvania Ave., #20, Deland, FL 32720.

ARTICLE TWO:

The duration of the non-profit corporation is perpetual, with commencement at the time of filing these Articles.

ARTICLE THREE:

The general purposes for which the non-profit corporation is organized are:

1. To transact any lawful business for which non-profit corporations may be incorporated under the Florida General Corporation Act, or engage in any other trade or business which can, be advantageously carried on in connection with or auxiliary to the foregoing business.

2. To assist and provide information for the mentally and physically challenged, in order to help them obtain vocational rehabilitation, medical treatment, employment opportunities, pen-pals and to also develop and market a challenged information CD.

3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

ARTICLE FOUR:

The street address of the initial registered office of the corporation is 114 West Rich Avenue, DeLand, Florida 32720, and the name of its initial registered agent at such address is MICHAEL S. TEAL.

ARTICLE FIVE:

The board of directors shall never have less than three directors and shall be elected or appointed as is stated in the bylaws.
