We, the undersigned, with other persons being desirous of forming a non-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

Article I

The name of the corporation shall be:

T.R. ROBINSON HIGH SCHOOL ALUMNI ASSOCIATION  
AND EDUCATIONAL FOUNDATION, INC.

Article II

Said corporation is organized exclusively for charitable, religious, educational, literary, and scientific purposes within the meaning of section 501(c)(3) of the Internal revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more

organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

The purpose of this corporation is to further the educational and extra-curricular activities at T.R. Robinson Senior High School, Tampa, Florida.


### Article III
