The undersigned being one (1) in number, hereby for the purpose of becoming a corporate body, pursuant to Chapter 617, Florida Statutes, does hereby certify and make, subscribe and acknowledge, and file in the Office of the Secretary of State of the State of Florida, this Certificate:

**ARTICLE I**

The name of this corporation shall be known as **Lahaina Dance Productions, Inc.**, and the initial address of the corporation is 2107 Coral Creek Drive, Pensacola, Florida 32506, and the name of the registered agent at such address is Cereza D. Davis.

**ARTICLE II**

The period of the duration for this corporation is perpetual, unless dissolved according to law. The corporate existence shall commence on the <sup>1st</sup> ~~31~~ <sup>OCTOBER</sup> day of ~~August~~, 1998. *C Davis*

**ARTICLE III**

This corporation is nonprofit organized for the following purpose:

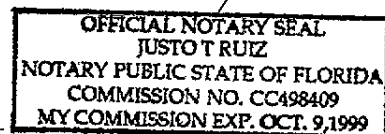

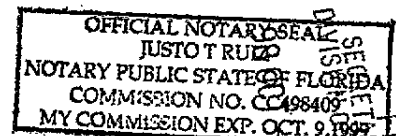
