The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617 of the Florida Statutes, adopt(s) the following Articles of incorporation:

**Article I  
Name**

The name of the corporation shall be **THE RECIPE COLLECTION, INC.**

**Article II  
Principal Place of Business and Mailing Address**

The principal place of business and the mailing address of this corporation shall be:

**Article III  
Purpose**
