## ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation is an actual person competent to contract and hereby form a non-profit corporation under Chapter 617 of the Florida Statutes.

### Article 1-Name

The name of this corporation is Legal and Public Affairs Support Foundation, Inc.

### Article II-Purpose

Legal and Public Affairs Support Foundation, Inc. is organized for the purpose of:

- a) To help provide educational enrichment activities for students enrolled in the Academy of Legal and Public Affairs at Coral Reef Senior High School.
- b) To identify resources that are available for enhancing the programs and activities offered by the Academy of Legal and Public Affairs Academy at Coral Reef Senior High School.
- c) To increase the level of awareness in the community about the importance of legal and public affairs education.
- d) Provide recognition and scholarships for outstanding students in the Academy of Legal and Public Affairs at Coral Reef Senior High School.
- e) Assist in fund raising to support promotional and academy activities.

### Article III Principal Office

### Article IV-Prohibitions

No part of the net earnings of the corporation shall inure the benefit of, or be distributable to its members, trustees, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensations for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on for propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) and political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax section 501 (c) (3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## **Article V-Term of Existence**

This corporation shall have a perpetual existence.

## **Article VI-Dissolution**

Upon dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed of by Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
