WHEREAS, the name of the Corporation is TO THE NATIONS, INC.; and

WHEREAS, the Corporation was incorporated pursuant to the provisions of the Florida General Corporation Act, on August 20, 1998 and assigned document number N98000005762; and

WHEREAS, the undersigned Corporation, by and through its Directors and Members pursuant to the provisions of Section 617.1001 of the Florida Statutes, wish to amend the aforesaid Articles of Incorporation; and

WHEREAS, the Board of Directors and Members of the Corporation acting by unanimous written consent have unanimously agreed to amend the aforesaid Articles of Incorporation in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article I - Name of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I - Name

The name of this Corporation shall be:

ENCOURAGING GOD'S SERVANTS, INC."

2. Except as modified herein, the Articles of Incorporation of said Corporation shall be and remain in full force and effect.
