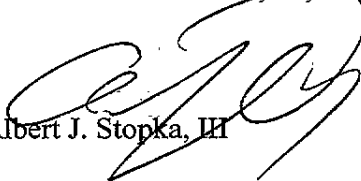

ARTICLES OF INCORPORATION

OF

**SILHOUETTES OF THE WORLD, INC.,
a Not for Profit Corporation**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be **Silhouettes of the World, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The street address of the initial principal office and mailing address of this corporation shall be 1407 Tennessee Avenue, Lynn Haven, Florida 32444.

ARTICLE III - PURPOSE

The corporation is a not for profit corporation. The purpose for which the corporation is organized is:

(a) The specific and primary purpose(s) for which the corporation is organized is to provide counseling, facilitation, and training programs to individuals and families requesting assistance.

(b) The general purpose for which the corporation is formed is for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify

as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

(c) This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation, nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office, except that the corporation shall be allowed to appear before and submit proposed legislation of direct interest to the corporation and any communication information between the corporation and its clients regarding local legislation or proposed legislation of direct interest to the organization or its members.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The corporation shall not have fewer than three (3) directors. The exact number of directors shall be set by the bylaws. The manner in which the directors are elected or appointed shall be the method as stated in the bylaws.

ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and Florida street address of the initial registered agent is Albert J. Stopka, III, 108 Mosley Drive, Panama City, Florida 32444.

ARTICLE VI - INCORPORATOR

The name and address of the Incorporator to these Articles of Incorporation is Dawn M. Roberts, 1407 Tennessee Avenue, Lynn Haven, Florida 32444.

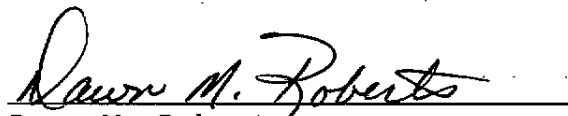
ARTICLE VII - PROPERTY DEDICATION

The property of this corporation is irrevocably dedicated to the purposes stated herein and in the bylaws, which purpose shall be consistent with section 501(c)(3), Internal Revenue Code, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member, or to the benefit of any private individual.

ARTICLE VIII - DISSOLUTION

On the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed as for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

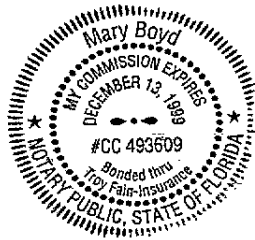
