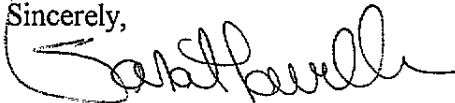

ARTICLES OF INCORPORATION
OF J.P.'s HOUSE, INC.
A FLORIDA NONPROFIT CORPORATION

Article 1. Name: The name of the Corporation is: J.P.'s HOUSE, Inc.

Article 2. Duration: The duration of the Corporation is perpetual.

Article 3. Purposes: The purpose of the Corporation is as follows:

A. This corporation is a not for profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to provide housing, food, education access and vocational experiences for youth who have been displaced from their homes due to homelessness, parental abandonment or other circumstances beyond their control.

B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers, but the Corporation shall be empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members: The Corporation shall not have members or shareholders.

Article 5. Initial Registered Agent and Office: The initial registered agent is Sara Howeller, 2380 Pemberton Street, Oviedo, FL 32765 and the initial registered office is 2380 Pemberton Street, Oviedo, FL 32765.

Article 6. Initial Board of Directors. The initial Board of Directors shall have (minimum of 3) directors, whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

Article 7. Officers: The officers of the Corporation shall consist of a President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. The name and address of each initial Officer of the Corporation is as follows:
