ARTICLES OF INCORPORATION FOR NOT FOR PROFIT

**ARTICLE I
NAME AND LOCATION**

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The name of this organization shall be SOUTHEAST CHRISTIAN CHURCH of JACKSONVILLE, FLORIDA, INC. and its location shall be Jacksonville, Florida.

**ARTICLE II
PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS**

The church meets in The Landmark Middle Schools for its worship services. The office and mailing address is 3839 Luth Dr. E., Jacksonville, Florida 32250.

**ARTICLE III
PURPOSE**

The purpose and general nature of this corporation as an organization of Christians shall be the maintenance, promotion, teaching, and generally furthering of the church, teaching and preaching the Gospel of Jesus Christ and the advancing of His Kingdom throughout the world as set forth in that portion of Scripture known as the New Testament. More particularly to own and maintain facilities for public worship and to provide for worship and religious instructions and other Christian activities. To this end it shall have and exercise any and all of the rights of a corporation not for profit.

**ARTICLE IV
MANNER OF ELECTIONS OF DIRECTORS**

Elders: The elders shall be members of this congregation, who in the opinion of the membership, best meet scriptural qualifications of I Timothy 3:1-7; and Titus 1:6-9. Their duties shall be carried out as prescribed as in the New Testament, to oversee the congregation and to be shepherds of the Church (I Peter 5:1-5). The Board of Elders shall not be less than two men.

Officers: The officers of this corporation shall constitute a Church Board (board of directors), which will consist of the Elders and the Deacons of the Church. From this number shall be elected Board Chairman, Vice Chairman, and Treasurer of the Church. The Chairman of the Board shall be ex-officio of each committee appointed or constituted under this charter or any by-laws amended and adapted hereafter.

Each year at the annual meeting the congregation is invited to submit nominations for the work of an elder three weeks prior to the annual meeting. The nominations will be given to the elders and senior minister for screening after which the elders will present a list of names two weeks prior to the election to the congregation.

At the annual meeting the nominees will be voted on by a printed ballot, requiring 3/4 majority vote.
