ARTICLES OF INCORPORATION

OF

MESSENGERS OF HOPE MINISTRIES, INC.

PASSOR IN MOSON

The undersigned, acting as incorporator of a non-profit corporation under the Not for Profit Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is Messengers of Hope Ministries, Inc.

ARTICLE II - TERM OF EXISTENCE

The period of duration of the corporation is perpetual.

ARTICLE III - NATURE OF BUSINESS

This corporation is organized for the purpose of positive spiritual messages and any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV - MEMBERSHIP

The qualifications for membership and the manner of admission shall be as regulated by the by-laws.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE IX - DUTIES AND POWERS

Messengers of Hope Ministries, Inc. shall be a non-profit corporation and shall have all the duties and powers of non-profit organizations, and no member, officer or director shall be authorized to do anything inconsistent with a non-profit corporation. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to it's members, trustees, officers or other private persons, except that the corporation shall be authorized to and empowered to pay reasonable compensation for services rendered to and make payments and distributions in furtherance of the purposes set forth in Article III. No substantial part of any of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal Tax Code; or a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code or the corresponding section of any future Federal Tax Code.

ARTICLE X - BY-LAWS

The by-laws of the corporation shall set forth in detail the qualifications for membership and voting rights.

ARTICLE XI - AMENDMENT OF ARTICLES OF INCORPORATION

The members shall have the power to adopt, amend, alter, change or repeal the Articles of Incorporation when proposed and approved at a called membership meeting, with not less than a three-fourths vote of the members.

ARTICLE XII - DISSOLUTION OF CORPORATION

Upon dissolution of the corporation, the assets of the corporation remaining after payment

of all debts and liabilities of the corporation shall be distributed to an organizational agency and used exclusively to accomplish the primary purpose for which the corporation is organized. If the corporation holds any assets in trust, such assets shall be disposed of in such a manner as may be directed by an order of the Circuit Court of Duval County, upon petition by the Attorney General or by any persons concerned in the liquidation in a proceeding to which the Attorney General is a party or any procedure establish by the laws of the State of Florida.
