ARTICLE I  
NAME

The name of the corporation is  
MY CHILD MAGAZINE TRAINING INSTITUTE - MCMTI, INC.

ARTICLE II  
PRINCIPAL OFFICE

ARTICLE III

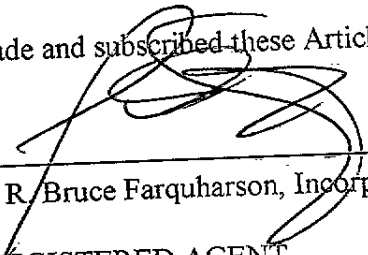

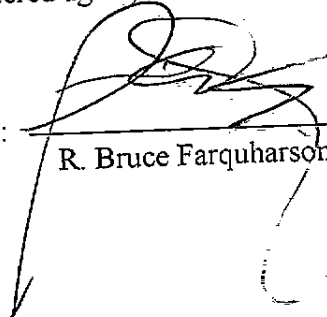
