The corporation shall have members as set forth in the By-Laws.

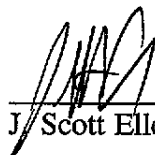
ARTICLE VII is amended to read:

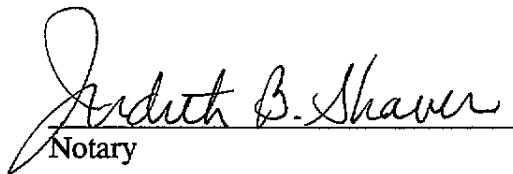
